Effective April 1, 2009 Travelport will charge a \$20.00 monthly fee for each Travelport Cruise & Tour license/logon user. This charge applies to all customers regardless of an agency's segment levels. The fee will be included as a new line item on your monthly statement and/or invoice. You will see the new line item on your May statement for April usage. Credits that apply to Travelport Cruise & Tour will not change.

Why are we now charging? Until now, Travelport has incurred all license fees and development fees. In the current economic conditions, it is necessary that we pass a small portion of these license fees onto the agency.

The product licenses can be adjusted at any time. However, in preparation for the new pricing structure, we recommend you evaluate your number of licenses and make the appropriate adjustments by March 31st. Meeting this deadline ensures that you will be charged for only the licenses you need.

In the development of Travelport Cruise & Tour, Travelport partnered with a 3rd party recognized as an industry leader, allowing us to provide the best cruise and tour shopping capabilities available. Our product simplifies the process by offering you the ability to shop across all cruise suppliers in one single request. In addition, all applicable rate codes are displayed in a single request. Efficiencies such as these improve agent confidence in selling cruises, enabling your agency to close more sales and increase agency revenue.
