Detail and Customer Examples


- 1. Pricing Matrix
 - a. The pricing matrix is available when using either Quick Cruise or Fast Path.
 - b. The pricing matrix will be displayed at the Category Selection process.
 - c. The matrix will display prices from lowest to highest.
 - d. Once a price is selected, the booking is processed as usual.


2. Category Upgrade

Upgrades are available for certain sailings, promotions or contracted rates. If an upgrade is available for booking, a green arrow will appear in the pricing matrix. When hovering over the arrow, the cabin number that appears will show the priced cabin. The actual cabin upgrade is the cabin number in the left column of the display.





3. Expanded Cancelation Policy
Agents can now click on the cancellation policy link and a pop-up will appear which will
list each cruise line and a link to their full cancellation policy.



- 4. Less Than Minimum Payment.
 - a. This allows for arbitrary payments to be entered in the payment field, including less than the minimum payment if it's before the due date or for subsequent payments prior to the full payment date.
 - b. Email reminders will still be activated to fulfill deposit and final payment requirements.
