#### **Overview**

Currently Travelport Cruise & Tour supports First/Main seating or Second/Late seating for dining options. Royal Caribbean/Celebrity and Azamara will now offer Flexible Dining options on certain ships and sailings that Travelport Cruise & Tour cannot support until 4Q 2009. Some of the new options allow passengers to select a specific time for dining. The new options require pre-paid gratuities be added to the booking for RCCL and CEL options, but are elective on AZA.

If a Travelport Cruise & Tour booking is made and subsequently the user makes changes directly with the cruise lines which involve a Flexible Dining option, certain responses and default functionality will occur. Once a change has been made to a booking that includes a Flexible Dining option, it cannot be changed again in Travelport Cruise & Tour and all additional modifications must be made directly with the cruise vendor. The default functionality will be that the reservation is locked from any dining changes and the option to change is grayed out (inactive). The history will display the changes that were made to the reservation. The Prepaid Gratuities will be added and can be changed only if the booking is changed back to a Traditional dining option and this will have to be done by the cruise lines.

Flex Dining changes that will affect a reservation include:

- 1. If all passengers change to Flexible Dining or one passenger in the reservation has a first or second dining selection and another in the same reservation changes to a Flexible Dining option, the booking will be locked from making changes and any modifications need to be made directly with the cruise line. Information regarding the changes can be found in history. (See examples 1 and 2 below)
- 2. If an attempt is made to create or bridge a cross reference reservation that has traditional dining with one that has a flexible dining option a warning message will appear and cross reference will be prohibited. (Similar to current functionality where cross reference with different dining options is not allowed, even if Flex Dining is not a factor)
- 3. If Prepaid Gratuities are added as a result of a reservation being changed to a Flex Dining option and will be reflected in the invoice.(See example 3 below) The gratuities can only be modified by the cruise line for RCCL and CEL. Azamara Prepaid Gratuities are optional, and therefore can be changed.


