PARTIES

OCTOPUSTRAVEL.COM (AUSTRALIA) PTY LTD ACN 099 122 577 of Level 1, 655 Pacific Highway, St Leonards NSW 2065 ("Octopustravel").

SUPPLIER means the Supplier named in the Schedule.

RECITALS

- **A.** The Supplier supplies goods and or services to Octopustravel, which attract goods and services tax ("GST").
- **B.** Octopustravel wishes to create its own tax invoices in relation to the supplies by the supplier ("Recipient Created Tax Invoice").
- C. The Supplier and Octopustravel wish to enter into a written agreement authorising the issue of the Recipient Created Tax Invoice by Octopustravel, in relation to the supplies by the Supplier.

AGREEMENTS

1 DEFINITIONS AND INTERPRETATION

1.1 Definitions

1.1.1 Where commencing with a capital

"Recipient" means Octopustravel.com (Australia) Pty Ltd

"Recipient Created Tax Invoice" means a tax invoice issued by the Recipient ("RCTIs")

- "Supplies" means the supply of goods and or services referred in the Schedule
- **"Supplier"** means the supplier whose details are included in the Schedule.
- 1.1.2 Where any word or phrase is defined any other part of speech or other grammatical form in respect of that word or phrase has a corresponding meaning.

2 RECIPIENT CREATED TAX INVOICES

2.1 The Supplier and the Recipient agree that:

- 2.1.1 the Supplier has and will continue to supply to the Recipient the Supplies referred to in the Schedule;
- 2.1.2 the Recipient can issue tax invoices in respect of the Supplies;
- 2.1.3 the Supplier will not issue tax invoices in respect of the Supplies;
- 2.1.4 the Supplier acknowledges that it is registered for GST and that it will notify the Recipient if it ceases to be registered for GST;
- 2.1.5 the Recipient acknowledges that it is registered for GST and that it will notify the Supplier if it ceases to be registered for GST or if it ceases to satisfy any of the requirements of the determination.

3 GENERAL

3.1 Costs and Expenses

Each party will be responsible for their own costs and expenses in the preparation and execution of this agreement.

3.2 Governing Law

The Laws of New South Wales govern this agreement.
